Methodology:

In order to conduct the Internal Academic Audit, we have designed a 10 point data format through which relevant academic data have been collected from various departments of the college.(Specimen copy of the data format is enclosed herewith). The data collected from the Departments have been meticulously analysed by the Committee in order to ascertain the academic quality being maintained by each department.

Findings/observations:

On the basis of the inputs received from various Academic Departments we have arrived at the following findings.

- 1. There are altogether 13 Academic Departments in the college. All the Departments are running programmes as per permissions /affiliations received from the Affiliating University. The Department of Commerce is functioning on self-financing basis.
- 2. Out of 13 Academic Departments, 11 departments including Commerce are offering both Major/Honours and General Courses while two Departments i.e, Departments of Geography and Mathematics are offering only General /Regular Courses at UG level.
- 3. CBCS Courses have been introduced by all the Departments in tune with UGC guidelines from the current academic session.
- 4. As in the previous year, this year also the Departments are facing shortage of sanctioned faculty to run their programmes due to which non-sanctioned/contractual teachers are recruited. Shortage of faculty has also resulted in unreasonable PTR in most of the Departments.

- 9. The Results of the Final examinations in respect of all the Departments are found to be satisfactory although there is scope for further improvement of results.
- 10. The practice of making drop out analysis also exists in all the departments.
- 11. All the Departments are found to have taken remedial classes for the slow learners .
- 12. A few departments like Education, , History, Arabic , Philosophy , Hindi, Commerce and Environment Studies are found to have undertaken project works as a part of their syllabus.
- 13. There has been a healthy practice of showing the answer scripts of the Sessional Examinations to the students of each Department which ensures transparency in the internal evaluation system.

Suggestions:

- 1. In view of growing enrolment each year, urgent measures have to be taken by the competent authority to sanction more posts to the needy Departments.
- 2. Steps need to be taken to provide more ICT facilities for ensuring ICT enabled teaching-learning.
- 3. Intake capacity of the Major Courses need to be increased subject to the approval of the affiliating university.
