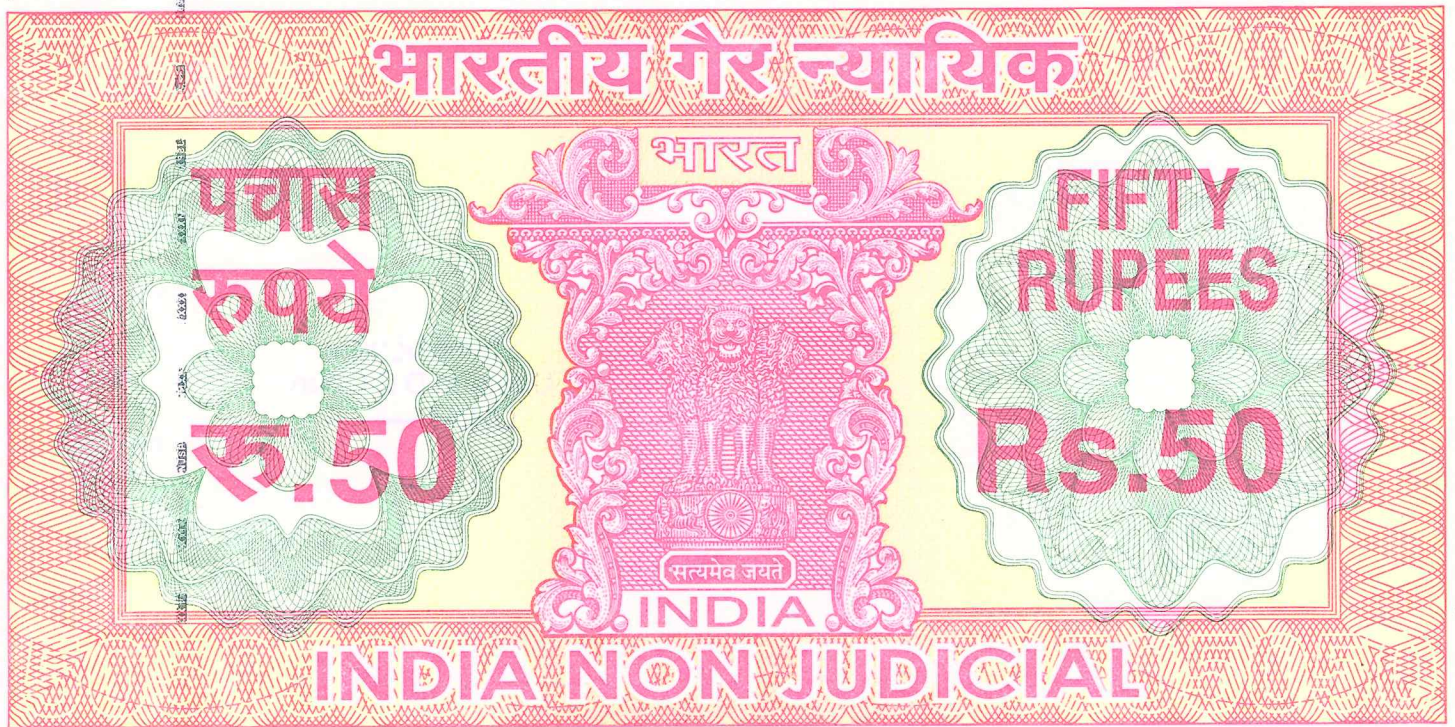

represented by its Programme Director namely **Mr. Shanth Krishna**, hereinafter called the SECOND PARTY, an organisation that is rooted in the belief that as an organization it aims to develop a cadre of leaders exposed to the complexities in the process of bringing change in social and public systems.

### 1. Objectives of the Agreement

The objective of this Agreement is to establish new partnerships for developing local college students for the betterment of society and making them skilled. So that they understand their contribution in society through real ground practical experiences and taking Social Entrepreneurship as a career choice and so to introduce **Youth Volunteership program** in Personality Development for the outgoing students ready for their professional journeys.

### 2. Modes of Collaboration

- ❖ Both the organization and the institute can use each other's logo to show their collaboration and brand-related Activities in their publications.
- ❖ Both parties have agreed upon setting up a Faculty Exchange/Expert Exchange Program from the academic session 2022-23 onwards for knowledge sharing and spreading awareness regarding Social Entrepreneurship. As a part of this agreement an orientation programme has already been organized at the college campus on 17<sup>th</sup> February, 2023.
- ❖ The organization will run a **Youth Volunteership program** with all the selected college students.
- ❖ The organization will provide free of cost online reading material to the



participants relevant to the course modules.

- ❖ The institute will support the organization during the recruitment process of the volunteership Program.
- ❖ The institute will provide space and support to the organization in conducting events, capacity-building weekly sessions, debriefs, and other activities for the students during the process.
- ❖ The organization will make year long program with 3 stages to support youth in their career.

### 5. Non-negotiable

The POSH policy will be applied to all the members of the program including the people from the Piramal Foundation and the participants youths and Faculties from the college and also people of the Institute.

### 6. Terms & Conditions

This Agreement may be amended, renewed, and terminated at any time by mutual written agreement between the institute and the organization. Either Institute or the organization shall have the right to terminate this MoU upon 30 days of termination notice.

## **7. Confidentiality**

- ❖ **KHARUPETIA COLLEGE, KHARUPETIA AND PIRAMAL FOUNDATION** agree to hold in confidence all information/data designated by the organization/ Institute/ College during the performance of the agreement and will not disclose the same to any third/outside/unknown party without the written consent of either of the party in agreement.
- ❖ The above confidential clause under this Agreement excludes the information/data possessed by either institute/organization before entering into this Agreement or independently developed and/or information already available through the public domain.

## **8. Duration of Agreement**

- ❖ This Agreement, unless extended by mutual written consent of the institute and the organization, shall expire in 1(one) year after the effective date specified in the opening paragraph. However, on review, the Agreement shall be extended for another 1(one) year by mutual consent.

## **9. Coordinators**

- ❖ Both Institutes will designate persons who will have responsibility for the co-ordination and implementation of this agreement.


## **10. Intellectual Property Rights (IPR)**


